# 40/20-21 COUNCILLORS' REPORTS.

Cllr Jones said he was about to contact Island Roads again about the planned double yellow lines in Hillcrest. Cllr Hastings suggested Cllr Ward be kept in the loop. Cllr Willis said the decision for the original planning application on land behind the Co-op was being appealed, despite the subsequent more modest application. There was discussion about Christmas mince pies and it was agreed to support this. Cllr Wills said she had received thanks from a local resident for the tree lights. She said Island Roads 'closure' of Highwood Lane for surveying had proved somewhat illusory. Cllr Hunt commented about the loose manhole cover outside his property and Cllr Hastings provided a contact for Southern Water on the island. Cllr RigaudBarrett had attended the on-line meeting with the IWC Leader on next year's budget and COVID-19 response. Some concern was expressed about visitors to the Island (Tier 1) from Tier 2 and 3 locations and how this would be controlled. Cllr Hastings suggested an e-mail to IW Cllr Mosdell. A village newsletter was planned for January.
